

Carlyle takes over food services

Southern Polytechnic has a new food service company: Carlyle's Corporate Catering. ABL Inc., the former food service, served SPSU for the last five years. A lot of students who eat in the cafeteria are happy to see ABL go and have high hopes that Carlyle's is an improvement.

Carlyle's is a company based out of Atlanta and has been in business for 31 years. They serve on other campuses in Georgia, like Georgia Tech, Emory, Georgia State, and Shorter College. Even though they have served on other campuses, SPSU is a new challenge to them because this is the first time they are in charge of all the food services on a campus. They have a 5500 square foot commissary six miles from campus. This commissary is where all the catering food will be made and then brought to campus. The on campus kitchen will only make the food for the Community Center coffee house, the Student Center grill, and the cafeteria. Carlyle's makes both catering and cafeteria food fresh everyday and all their food is

When SPSU opened bidding for the food service contract, only two companies made bids: ABL Inc. and Carlyle's Corporate Catering. A committee was put together of faculty, staff, and students to compare and make a recommendation to Patrick McCord on which company was better. The committee's part was to determine if the companies could provide the service SPSU needs and compare the quality and taste of the food each company produced. Both companies made presentations about their services, gave samples of their food, and in Carlyle's case, set up an on site visit for committee members at one of the campuses they are already at. After all this was finished, the committee concluded that both Carlyle and ABL could provide the services needed but that Carlyle's had better tasting and quality food. The committee's decision then went to Patrick McCord who reviewed the financial packets for each company. Carlyle's, again, beat out ABL with a cheaper financial packet. Robert Whitaker stated that Carlyle's was the "best solution for Southern Poly" both in price and quality.


One of the new additions

Carlyle's brought to campus is Starbucks coffee in the Community Center. The Community Center coffee house serves the regular Starbucks coffee, mochas, frappuccinos, etc, but they also have the teas. They are planning to gradually add Starbucks treats to

the menu, but at this point the only foods served are salads and sandwiches. Right now, an employee from Carlyle's is running the coffee house, but starting September 4th, Carolina Daza, the Student Government President, will be taking over as manager. The Community

Center will be open from 7:00 am to 2:00 pm and after August 28th, they open again at 5:00 pm to 9:00 pm.

In the Student Center, Carlyle's has changed the looks of both the cafeteria and the Student Center grill. The grill changed from a Continued on Page 2



Housing update


For the first time since the Courtyard, Southern Poly's new apartments, were built, on-campus housing is almost full.

One reason housing is so full is that not all the students living on campus are enrolled at Southern Poly. Students from other colleges, like Kennesaw, Georgia Highlands, and Chattahoochee Tech, are also living here. Why have students from these schools decided to live at SPSU? Since Georgia Highlands has a satellite campus here at SPSU, students attending classes here have decided that it is more convenient to live at SPSU. Chattahoochee Tech has no on-campus housing and SPSU is only a few miles down South Cobb Drive. Kennesaw students are coming to SPSU housing because housing at Kennesaw State is full.

Another reason for the increase in people on campus is that all freshmen have to live on campus, except if they are 21 or older or are living with a guardian. The decision to require freshmen students to live on-campus was made because research has shown that retention is higher for students that live on-campus. Housing is also trying to set freshmen up for success by group them by majors and by having more resident assistants in Howell Dormitory (freshmen dorm) to help the freshmen out.

Students, who are thinking about moving on campus, are advised to apply soon. There is a waiting list already for female applicants and there are only a few beds left open for male applicants.

Last year, housing was only around 85 percent full, but as of now, housing is around 95 percent full. Also, there is a 15 percent increase in the number of women living on campus.

Career Connection

Myspace: job hazard?

It was not so long ago that the "buzz" around the college campus in which I worked some years ago was the internet. There was much excitement about what this online tool would do to make life easier for career services professionals and the way that students would search for jobs.

Today the "buzz" is surrounding the use of social networking sites such as Facebook, MySpace, LiveJournal, and Friendster just to name a few. Social networking sites allow people to post profiles of themselves and other materials such as pictures and blogs online. The prevalence of this activity is astounding and the practice of doing so has become a cultural phenomenon in a short period of time. MySpace is currently the most popular networking domain among the general public, even more so than Facebook. One reason is that Myspace is open to everyone over the age of 14, while Facebook restricts users to those with a valid e-mail account that ends in ".edu." Users are encouraged to log in and create a profile to share information, photos, and interests with their friends.

The reality is that it's not just friends who view these profiles. Recent information about how often employers where viewing these online sites in the candidate screening process prompted the National Association of Colleges and Employers to conduct a "quick poll" on the practice of "Googling" candidates or reviewing their profiles on social networking sites (such as Facebook or Myspace) and more than one-quarter of organizations reported that they have done so at some point.

How do you prevent social networking sites from having a negative impact on your job search? First, know what is out there. Spend time to actively investigate what information is available about you online. One way is to use a search engine such as Google to look up your name to find out what information is attached to you. Perhaps there may be information posted by others of which you are unaware.

Second, determine if you should revise the content listed in your profile. It is important that you post responsibly and think about possible future consequence of the information shared on networking web sites. Rumors that offers for interviews and positions are being pulled because of information posted on these networking sites have begun to circulate.

An example of how information posted could damage your job search is that if an employer decided that you and another candidate are finalist for a position and you both have equal attributes for the position, but the information posted on your Facebook page leaves a bad impression, the employer could decide to eliminate you from consideration.

Social networking sites are likely here to stay. Whether they have a positive or negative impact on your job search is up to you. It is very important that you remain educated on how to utilize social networking sites to become a valuable tool not only in social connections but also in connecting with employers. Parking Tickets

Read and prevent losing money

Parking tickets from campus police may seem to be a nuisance designed to upset you or gain revenue for the school, but the true reason is to regulate—through negative reinforcement—the organization of our lots for the benefit of all students and faculty.

All parking lots and parallel spaces on campus are labeled at the entrances to each section describing what demographic is allowed to park there. For example, the large lot in front of the Wellness Center is reserved for commuter students and residents, split by a median. Though some lots may seem "perfectly positioned" in regards to your classroom building, they are not always open to your specific parking decal designation.

If you receive a parking ticket and feel there is enough reason for clemency (dismissal or reduction for your ticket), you have the opportunity to appeal. Appeal forms are located on the Student Government Association (SGA) office door in the Student Center and in the Campus Police station. In order for your appeal to be heard or read by the SGA Judiciary Cabinet, it must be filled out accordingly to the terms written on the appeal form. Some appeals have been dismissed without a hearing for improper completion, resulting in the full amount fined being owed to the Business Office.

No matter how far you travel to this college, or how late you are to class, it is monetarily beneficial for you to take the extra one minute of walking time to park in the reserved lot designated for your decal.

Here are some helpful tips on SPSU parking:

- 1. Buy your correct decal PRIOR to the semester starting, don't wait for the deadline to approach...you'll miss it.
- 2. Learn the lots...too many students ignore the little signs at

each entrance to the lots and end up having to pay \$30 or more.

- 3. Double check and triple check your appeal form for completion...it may result in an expensive waste of time. You have to appeal within 10 school days of the date on the ticket.
- 4. Respect the rules...our police officers are AUTHENTIC. Trying to beat the system by not getting a decal is almost impossible; your car's information is recorded by the officers and placed in the computer system when your car is seen decal-less. They can (and do) tow.
- 5. Note the Judiciary Cabinet hearing schedule each semester if you are appealing and make sure to be present if you elect to do so.
- 6. Proof-read your appeal... the Judges are students like you and we have a sense of humor and no remorse when it comes to juvenile justifications and pointless excuses in each written appeal. Be honest and factual, not emotional and harsh.


Here's how the appeal process works:

- 1. The ticket is turned in to the SGA office or the Campus Police office with a completed appeal form.
- 2. The forms are consolidated and reviewed at the next Cabinet meeting.

- 3. After each appeal is read individually (or spoken for in defense by the accused student) the Judges of the Cabinet recommend a judgment and it is voted on by a show of hands.
- 4. The Chief Judge copies the terms of the judgment on the bottom of the appeal form and signs it, making the results official.
- 5. The head secretary of the Campus Police office compiles the results after each meeting and makes a contact list for the Chief Judge. The Chief Judge emails (or calls if email doesn't work) the students to notify them of either an acceptance of the appeal, reduction of fines, or complete rejection of the appeal.
- 6. The student(s) who owe fines after the appeal has been processed must pay the fine to the Business Office by the end of the semester in order to receive transcripts and schedule for classes.

The Judiciary Cabinet meets every-other Tuesday at Noon in the SGA Office in the Joe Mack Wilson Student Center starting August 29th, 2006 for the Fall Semester.







anyway.





Ico: a simple but unique tale about a young boy

Having been one of the earliest PS2 titles, these days few people of the next generation of gaming really care about old titles of the early 2000 era. Regardless, for those who are aware of this rare title, Ico is considered one of the best games for the PS2... and it shows. What is it, though, that makes it such a respected rare gem in the world of current generation systems?

Story: The story for Ico is a simple but unique tale. You control a young boy with horns, aptly named Ico, who is brought to an old, decaying temple against his will for a sacrifice. Luckily, Ico breaks free from his confinement but is trapped in the vast temple. He meets an encaged, angelic princess named Yorda shortly after his escape but as soon as she's freed from her own prison, shadow monsters appear to try taking her away. As Ico, it is your duty to protect Yorda from these shadow monsters and lead her throughout the castle so you may both escape.

One of the greatest elements of the story is its subtlety. There isn't much actual talking between the few characters. The real story

telling is told through the visuals of both the environment and the actions between Ico and Yorda. As you continue through the game, you begin to realize the feelings Yorda might have for her small savior. During the ending cut scene of the game, one may get a feeling of sadness and then joy. I won't spoil what happens, but it ends up being a satisfying ending.

Gameplay: For an early PS2 title, Ico has a more unique style of game play than even most current generation games and even some of the next generation titles. As soon as you find Yorda, you'll be leading her through the vast castle, braving through death-defying jumps and complex puzzles. Ico will climb chains, swing across ropes and, as the game booklet says, Ico will literally climb all over the castle in order to get through, but that's not the challenging part.

You see, Yorda isn't as nimble as the young Ico and relies on you to guide her through the castle. Sure, this does count as a game-long escort mission, which is so dreadfully despised by audiences, but it's not as bad as it sounds.

Shadows will appear frequently and it'll be up to Ico to fend off the creatures from grabbing Yorda and taking her to their dark realm. Fortunately, you have no

health to worry about while fighting the shadows. The only way you can die in combat is if Yorda is captured and even then, the game is forgiving, resetting from either a previous save or a checkpoint.

Combat isn't too complex. You just swing your stick (yes, your weapon for most of the game is a stick) at the shadows, and yet, somehow, the shadows present enough challenge as they shove you to the ground and go for Yorda. Regardless, Ico is not an actionoriented game. It's a game for the intellectual to test your mind on the puzzles of the castle, and by the end of the game, one can feel a sense of accomplishment. However, each puzzle only has one way to complete it and because of that replay value is low, but talk to few fans and they may say, it's not the puzzles that they replay the game for.

Graphics: Other than the sweet, romantic story, fans of the game replay the game for its incredible beauty. Even compared to most games today, the game's environment is a gorgeous living piece of art. By journeying throughout the outer walls of the castle, the world is brimming with life. Birds perch on the ground, pecking for worms in the grass-coated ground and fly off as you come near them, the trees sway slightly in the wind, and the

sun glistens across the water and aging ruins of the castle to brings a sense of wonder to players.

Sound: Music in Ico is practically non-existent. The only chance for music is either in important cut scenes, during fights with the shadows (and it's more like haunting wind than music), and the ending cut scene. Still, the music works with the game's beautiful subtlety and each moment there is music, it feels right with the emotion.

While the game does lack world around you are all but limited. Your steps will echo throughout the corridors of the massive dungeon, while animals chirp and beat their wings against the faint whisper of the wind. It's almost satisfying to just stand upon the

edge of a cliff and let yourself be embraced in the aura of the sounds of life around you. In the sound department, Ico is almost as beautiful as it is visually.

Fun Factor: Is Ico a fun game? If you love doing geographical puzzles, then yes. Ico is very fun. It's almost like what a game of Indiana Jones should be like; more focused on surviving the traps and figuring how to get around huge ledges than the combat. If you want the game for pure fighting though, in music variety, the sounds of the it is best you that look elsewhere. Unfortunately, it is very difficult to find copies of Ico. So if you're an intellectual and want to try an old, but rare treat, Ico is a good pick up: especially considering that it might be cheaper than most new games to come out. I give it an 8.5/10.


Where: Marietta Square

What: I think of it as an adult Chuck E. Cheese. It's a huge game house and restaurant with all kinds of ticket games including assorted video game simulators, billards,







Ah, Final Fantasy. How long has it been? ... Actually, not that long. If memory serves you, they just recently released Final Fantasy XI: Treasures of... What was it? Aht Urgan or something like that?

Square, you really need to put more thought into your names instead of just throwing words at the fridge to decide your next big title. And just a few months before that, you released the much anticipated movie-sequel to Final Fantasy VII, Advent Children. Now you have ANOTHER sequel to that particular series? Dirge of Cerberus, you say? Once again, Square, stop with the throwing words at the fridge.

Yes, another year, another 3 Final Fantasy related items already released? Not to mention, Final Fantasy 12 later this year, but that's the future; we can wait for the future, so lets look at Dirge of Cerberus now.

Ever since the Tokyo Game Show of 2005, fans of Final Fantasy 7 have been eager for a chance to play through the world that established the series' popularity back in the 90s. However, this game takes the style and story of Final Fantasy and turns it into... a third person shooter?

That's right. Changing from the typical, turn based Final Fantasy mechanics from the days of yore, Dirge of Cerberus has decided to be different. Gamers aren't strangers to side stories of games having a new style of play all together, but new things do not always mean a good game. Take Mortal Kombat - anyone remember Mythologies? It didn't do so well. But fear not, loyal Final Fantasy 7 fans, Dirge of Cerberus is amazing.

Let's break it down.

Story: A year following the events in Advent Children (which adds up to 3 years following FF7), Vincent is in the village of Kalm after receiving a cell phone message from Reeve, a friend of the party in the original. During a celebration in Kalm, however, the village is suddenly attacked by a mysterious army and Vincent jumps into action, both saving the villagers and working his marksmanship on the invaders, while eventually meeting up with Reeve and his own World Relief Organization (WRO) to combat this force.

But what is this army? Where did they come from? Why are they attacking? As you progress along with Reeve, visiting locales such as the city of Edge (from Advent Children) and Nibelheim, you slowly discover the facts behind this army and its elite squad of super soldiers, known as the Tsviets. All the while, players will learn about their demonic hero and why he is the way he is, as well as his relation with Lucrecia, a side character barely seen in the original.

The story progresses nicely to put it simply, though people who have never looked into Vincent's past may be confused about cut scenes concerning the gunman's history, since they occur at random moments. Not to mention, his past isn't shown from beginning to end. Vincent's past works more like... beginning to middle to a little before to just before the end to the beginning again to a little after the middle and THEN the end. Still, if you know your Final Fantasy 7, then the cut scenes are interesting, especially near the end.

I did find two main gripes about the story though. One – the

cut scenes can be painfully long. Not as long as Xenosaga was, but it is still about 15 minutes long in between levels. Annoying? Most definitely. Two - I used to see Lucrecia as a mysterious woman with a sort of soft aura about her. All butterflies and gumdrops, so to say. She's still a nice woman, nicer than most other women on this planet, but she seems more... well... whiny and overdramatic to me now. I won't say what happens, but my respect for Lucrecia has gone down from playing this game.

Other than that, it's a good and nicely thought out story, especially for a shooter game. Is it as deep and complex as any other Final Fantasy game? Not a chance. Is it a bad story? Not at all.

Gameplay: As said, Dirge of Cerberus differs from other Final Fantasy by acting more like an action-oriented shooter game rather than a turn based game. How does this fare? It works pretty well as far as shooters go. Vincent can double jump, slash up enemies with his claw, transform into a devil version of himself, and most importantly, he can shoot; he can shoot REALLY well. There are three types of aiming for players to choose from. Automatic (which I presume automatically picks a target to shoot), semi-automatic (where you simply just aim in the general direction of range of the bullets, and the firing the enemy), and manual (it's all you with a little cursor to help). Is this bad? Yes, but only if you crave a challenge in combat. The assistance when using automatic targeting, or even semi-automatic target, takes the challenge (and sometimes the fun) out of blasting through dozens of soldiers. On the other hand, there are segments and boss battles that can be near impossible when just using the manual targeting setting, but if you want some difficulty in your game, I recommend you stick with manual control.

Speaking of soldiers, let's talk about them. These fearless killing machines will throw a lot of firepower at you. Granted, there aren't too many enemy types, but they can put up quite a fire. It's not

a game where you can run into the center of an enemy force and expect to win without a dire blow to your health. However, these soldiers aren't the brightest. They might put up a decent fight, but when they're constantly shooting behind a post that bullets don't go through and standing near explosive barrels, it's almost like they're asking to get killed. But regardless of their moments of stupidity you can and probably will die at least once or so to the sheer enormity of the attacking force.

One of the best features of the game is the customization you can do to your gun. You start off with Vincent's basic gun but within the first level, you'll find new barrels to attach to your gun, affecting stats such as the fire power, the rate of your gun. It is a lot of fun to experiment with all the items you'll acquire and change your pistol into a full fledged rifle and even a full automatic machine gun. In between levels, you can pay to upgrade your parts to you guns, both improving them in certain areas and sometimes weakening them in others. This part of the game is what really drew me in while I was playing it.

Graphics: In usual Square fashion, the graphics are beautiful... in their own gothic way. They certainly share many similarities to the popular Advent Children's graphics, which is good, considering the long cut scenes. Unfortunately, it seems that Square has forgotten to take the time to change the lip synching in the cut scenes

so it's very awkward to see the characters say one thing and then their lips go off saying something completely different. Other than that one problem, the graphics are very nice and the designs for the characters are creative, especially with the Tsviets and the remade models of Yuffie and Reeve.

Sound: Voice acting is fairly well. Not perfect, but good. The famous Steve Blum once again provides a surprisingly dark and moody tone that Vincent become popular for, and Yuffie's cheerful voice is always pleasing to hear (to my ears, anyway - don't know about you Japanophiles). The voices also bring players into the combat experience as enemy soldiers shout out orders while rushing into the area to get into position to take you out.

Musically, there aren't as many memorable tunes as the original but the music does its part in keeping you un-bored, which is always a good thing.

Fun Factor: Ultimately, is Dirge of Cerberus for everyone? Alas, it is not. Players who are strangers to Final Fantasy 7 or even Final Fantasy in general will probably be confused by some elements in the story. Still, the game is fun, even if it can be easy on semi-automatic (and beyond) targeting. If you're a fan of gothic-styled games or good gun customization or even just Final Fantasy, then there will be quite a treat when you play this game. Despite its flaws, I give Dirge of Cerberus a 7.5/10


SGA meetings occur every other Tuesday in the Library Rotunda. All students are invited to attend to witness first-hand the inner workings of the Student Government at SPSU.

Tuesday, August 29:

- The Internal Affairs Committee (IA) has recently passed an article of Standard Operating Procedures (SOP) that lists requirements for all organizations on campus.
- IA Committee announces that all student organization funds have been frozen until an updated roster is provided.
- An amendment to the SGA constitution (5.10) was passed allowing any member of the SGA to resign their position through a written letter, but that member will not be allowed back in if their position

has been replaced.

- By-laws were changed allowing parliamentarians and the Sergeant at Arms to receive stipends. Also, tardiness and absences to SGA meetings will receive a punishment based on the loss of a percentage of their stipend, rather than a whole dollar amount.
- Projects developing in the Public Relations department include publications released once a semester and open-forum talks based on various topics occurring monthly in the Community

SGA's Standard Operating Procedures

This document of Standard Operating Procedures, mandated by the Internal Affairs Committee (IAC) and upon approval of the Student Government Association (SGA) of Southern Polytechnic State University (SPSU), establishes policies affecting all recognized organizations on campus at SPSU. The protocol outlined in this document, with power granted by the constitution of the SGA, is to be strictly enforced by the IAC. No exceptions will be made. All SPSU student organizations will be held responsible for knowing all information presented in this document.

Article I. Requirements for becoming an officially recognized organization on campus SPSU by the SGA.

- 1.1 Potential organization must submit the following to the Internal Affairs Chair for review by the IAC.
- a. A Constitution and/or Bylaws of potential organization, with the organization's desired official name on the document. The constitution must state the purpose of the organization. The Constitution must be original and authentic. Each constitution received by the IAC will be reviewed against other organization's constitutions on file. If the organization requesting approval for recognition by the SGA council is found to have plagiarized an existing constitution, that prospective organization will be denied approval and all documents will be returned to the unofficial group.
- b. A roster of all members, including the Executive Board. The roster must include each member's name, address, email and phone number, as well as officer title, if applicable.
- c. There is no minimum number of students necessary to become an officially recognized organization; 1 person can be an organization. However, eligibility of receiving funds from SGA and an office in the Student Center will be discussed in Articles II and III.

d. A budget for the organiza-

tion, including organization dues, if applicable. If the organization wishes to receive funds from the SGA, they must submit a budget request detailing an approximation of what the funds will be used for. If approved, the IAC will propose recognizing that organization at the next general body SGA meeting. If not approved, the IAC will return materials to the potential organization with a synopsis of what must be changed in order to

resubmit.

- 2.1 Must be an officially recognized organization by the SGA. 2.2 **Definitions**
- a. Starter Budget Funds: Funds awarded by the SGA to an organization for use throughout the next fiscal year.
- b. Additional Funds: Funds requested by an organization outside of their starter budget funds in order to host or participate in an event, or to buy additional needed supplies. Additional Funds requests should be submitted to the Budget & Finance Chair for review by the Budget & Finance Committee (BFC)
- 2.3 An organization must have a minimum of 4 members at any given time in order to receive funds from the SGA. If membership falls below 4 members, starter budget funds will be frozen and no additional funds may be requested.
- In order to receive addi-2.4 tional funds outside of the starter budget funds, and organization should show proof of attempt at fund raising. Organizations that do not fund raise or do not plan to fund raise have little chance of receiving additional funds.
- The only exception to fund raising is if an organization is a nationally recognized organization that has a Not-For-Profit Clause. Any organizations that are unable to fund-raise for their own benefit need to show proof of community service projects that have

taken place either on or off campus SPSU.

Article III. Requirements to be eligible to receive an office in the Student Center.

- 3.1 Must be an officially recognized organization by the SGA.
- An organization who desires to have an office located in the Student Center must have a minimum of 4 members in order to be eligible.
- 3.3 Organizations who meet the minimum membership requirement should see the Assistant Director of the Student Center (ADSC) to have their organization put on the waiting list for an office.
- Organizations must agree to abide by the guidelines as described in Article V.

Article IV. Organization Status and Updates.

- At the beginning of Fall and Spring Semesters, all organization funds will be frozen until that organization submits to the IAC a current and up-to-date roster of all organization members. The roster must include each member's name. address, email and phone number, as well as officer title, if applicable.
- In addition to an updated roster at the beginning of each semester, a member of the executive board of each organization must submit a current status of their organization at the beginning of each full month of classes during each semester. IE: For Fall semester, status updates will be required in September, October and November. For Spring Semester, status updates will be required in February, March and April.
- Status updates will include if membership has increased or decreased. It will also include if any executive board members have changed (ie, if a member resigns, and a new officer is selected.) Each organization has 5 business days from the beginning of each month that updates are required to submit status updates to the IAC. After 5

business days, funds will be frozen IAC and the ADSC within the first until that organization submits their update.

Status updates may be 4.4 submitted to the IAC in writing at the SGA office, or by email to the Internal Affairs Chair.

Article V. Room Audits and Inspec-

- Room Audits will be conducted in the Fall and Spring Semesters
- Organizations with an office must adhere to the guidelines outlines in Article IV. Organizations with an office must submit their status update for the month of September within 5 business days, as described in Article IV. If that organization has not submitted their update on time, they have a 5 business day grace period to get their update submitted. If that organization still fails to submit their update by the end of the grace period, they will lose their office effective immediately, NO EXCEPTIONS.
- Membership numbers for eligibility for an office: if an organization has at least the minimum 4 members required to be eligible for an office, at the beginning of each semester when audits are conducted, they will not be audited based on membership again until the next semester. In other words, if an organization drops from 4 members to 3 or less during the semester, they will not lose their office based on membership requirements during that current semester. However, if by the time the next semester audits come around, if that organization has not brought their membership back to the minimum of 4 members, they will lose their office effective immediately once office audits have been conducted.
- If an organization loses their office, they will only be eligible to get an office back by following the procedures as described in Article 3, including being placed back on the waiting list by the ADSC.

Room inspections will be conducted by a member of the

week of each month, throughout the entire year. Inspections will be conducted in order to check for fire hazards, and safety & health issues. If the room is not up-topar, the IAC will submit a letter to that organization with a friendly reminder to please get their office within standards prior to the next month's inspection. An office inspection can be failed based on 3 things: Excessive messiness, Safety Issues, or Health Issues. If an organization fails 3 consecutive monthly inspections, they will lose their office effective immediately, NO EXCEPTIONS. This policy includes summer months; health and fire hazards don't take a vacation, and must addressed immediately.

Organizations will also lose their room effectively immediately if that organization is no longer officially recognized by the SGA.

Article VI: Electronic Records

- All organizations on campus must submit electronic records to IA. These records include the organization's constitution, roster list, and the letter from the Advisor. All budget requests must be electronic and sent to the B&F chair as well as the IA chair.
- The format of the documents shall be in PDF or DOC (Microsoft Word format.) No other formats are acceptable.
- The electronic copy of the constitution shall be named the following: Organization Name -Constitution - Date.doc
- 6.4 The electronic copy of the roster list shall be named the following: Organization Name -Member List – Date.doc
- 6.5 The electronic copy of the letter from the organization's Advisor shall be named the following: Organization Name - Advisor Letter - Date.doc
- 6.6 All changes to the constitution, roster list, or Advisors shall be submitted as hard copies and electronic copies to IA.




and improved Carlyle cafeteria.














