CLONE INVASION FORCE

(Editor's note: This story is from the Collegiate Hedlines service.)

Why would a young California man sell his car and furniture to finance a letter-writing campaign to newspapers and radio stations across the country?

Bill Hathcock did just that, sending letters of a "clone invasion" to the media. But he can't explain exactly why.

About 400 campus newspapers, along with several hundred other publications and radio stations, got Hathcock's letter signed by the "Clone Invasion Forces." Hathcock used his real name in the letter, stating that he is a clone and that he plans to retaliate against humanoid discrimination against clones, such as clone jokes. He is writing, he says in the letter, because "Someone on our staff (we can't tell who, as we all look alike) accidentally erased 18½ minutes of our computer tape containing the addresses of our clones, so we can't contact all of you to send you our battle plans." The

letter requests clones -- and humanoids who seek "special considerations"--to send a selfaddressed envelope to the "enlistment center" (P.O. Box 2469, Santa Cruz, Calif. 95063).

The letter also gave a phone number: (408) 426-7141. When Collegiate Headlines called the number, we got a recorded message in a Clonehead like monotone promising to return our call collect if we would leave our number. The next day a normalsounding Hathcock called back. He said he wouldn't classify his letter-writing spree as either a joke or an experiment. "I just wanted to see what kind of response I would get," he says. To date he has received over 100 letters ("A lot of them sound like they're crazier than I seemed to be in my letter.") and has had numerous telephone interviews with writers and broadcasters.

The "astonishing response prompted him to send a second letter to the same media list. "I'm just trying to give people something to think about. Some people think I'm actually serious and others write back humorous responses."

Governor Busbee and Ga.'s Budget



(Editor's Note: The following article concerns Governor Busbee's views on Georgia's budget.)

In the last four years, I have at all times tried to be candid about the financial facts of life in State Government.

Today I would like to be equally forthcoming about some conclusions I have reached concerning both the Immediate and Long Range Fiancial Future of State Government.

I have discussed these principles with Lt. Governor Zell: Miller and Speaker Tom Murphy and some of the leadership of the General Assembly and I am authorized and pleased to say that the budget principles which I am announcing today have their support.

As I begin the long process of reviewing all of the budget requests in state government and formulating my budget recommendations, I will operate within these principles:

First, the machinery of state government -- the departments, the agencies, the programs -- are not going to grow for the sake of growing. I am not sentencing these agencies to stagnation. On the contrary, I am inviting constructive and dynamic change but not growth. I want new approaches to providing government services. But not growth. I want our state government to be as modern, as innovative, as any state government in the nation. But I do not want growth.

I have been in state government 22 years and it is my observation that in the minds of government managers--in state government, the federal government and local government--progress is synonymous with growth. I am rejecting that notion. Compliance with these principles will, in many instances, be pain- trust is to practice what we ful and difficult for department heads and managers. This will require discipline, strong financial controls and good management. But I think it is vital that we make this commitment.



This year, I am not going to recommend any long term financing through bond sales and I want to carefully explain why. The reason is that it is much more financially responsible to use current revenues, or surplus funds, for necessary capital outlay projects than it would be to build these funds into programs that require recurring expenditures.

We are not over-bonded or overcommitted to long term financing. We have been very conservative in issuing new bonds in the last four years and this has been a hallmark of the financial management of state government which we have implemented during the last four years. But if we were to use these current revenues to expand programs--to fund popular and worthy programs--then we would build up what we refer to as "continuation spending" and we would be committing ourselves in all probability to a future tax increase in order to continue that level of expenditure.

In the summer of 1975, as our national economy experienced a severe recession, I took a number of financial steps in state govern ment which were responsible and necessary. Because the hard times were visible, I received very strong support for these measures from the men and women in state government and the people of the state.

Times are better now--or at least they appear to be better. But I am persuaded that with the rate of inflation we have today-and the obvious economic uncertainties that are part of a modern global economy--the dominant responsibility of those of us who hold positions of public preach--and that is respect for the taxpayer, commitment to efficiency and determination to put the brakes on growth in government.

These principles will guide my budget deliberations.

Second, we will balance the upcoming budget without a tax increase of any kind.

Third, I will carve out \$75 million which will be recommended for some type of meaningful and fair tax relief. I am making this announcement at this time so that the Tax Reform Commission will have the benefit of knowing what the Lt. Governor, the Speake and I believe to be a realistic level of tax relief to be provided in the 1980 budget. It would be premature to speculate today on the most appropriate mechanism to provide this tax relief, but I am confident that the Tax Reform Commission, the leadership of the General Assemb and my office can develop a workable and equitable recommendation for providing this tax relief.

My announcement of this figure today should in no way affect or limit the parameters of the Tax Reform Commission's Examination of our overall tax structure, bu it is obviously important that the commission know at this point in time our recommendation as to the amount of funds that should be devoted to tax relief in the 1980 budget.

The fourth important principl that will guide my budget recommendations this year will be a complete "pay as you go" approac I will recommend over \$100 million in capital outlay for schoo and prison construction and I will not recommend issuance of any new bonds.

It is customary in government financing to pay for such things as prisons and school buildings and other capital improvements by using long term financing which is obtained through the sale of bonds, usually repayable over a period of 20 to 30 years. This is the same type of long term financing an average citizen does when he gets a 30-year loan to build a house. The general idea is that the facility is to be paid for over the perio of its useful life.



"Are We Alone?" will begin at 7:00 pm in classrooms I & II at Fernbank Science Center. This lecture is offered to the public


free of charge and on a first come, first served basis. It is part of a continuing series of lectures co-sponsored by the Atlanta Area AAAS and Fernbank Science Center.




