A PROCLAMATION.

GEORGE R.

WHEREAS our Parliament stands prorogued to Tuesday the Nineteenth Day of this Instant October; We, with the Advice of our Privy Council, do hereby publish and declare, That the said Parliament shall be further prorogued on the said Nineteenth Day of October, to Tuesday the Sixteenth Day of November next. And we have given Order to our Chancellor of Great Britain, to prepare a Commission for proroguing the same accordingly. And we do hereby further declare our Royal Will and Pleasure, that the said Parliament shall, on the said Sixteenth Day of November next, be held and sit for the Dispatch of divers weighty and important Affairs: And the Lords Spiritual and Temporal, and the Knights, Citizens and Burgesses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required to give their Attendance accordingly at Westminster on the said Sixteenth Day of November next.

Given at our Court at Kensington, the Fourteenth Day of October, 1742, in the Sixteenth Year of our Reign.

Frederica in Georgia, July 9.

General Oglethorpe arrived here on the 6th by Day-break, without the Loss of a Man, having brought up all the wounded on his Horses. He immediately gave Orders for the Defence of this Place, and having sent out Scouts on all Sides, and supply'd the broken and lost Arms, &c. ordered all the Companies to be paraded. On the Afternoon of the same Day the Creek Indians brought in five Spanish Prisoners. On the 7th, the Kangers, who had been on the Scout, came in, being pursued by the Spaniards, and gave an Account, that the Enemy was within a Mile of this Place, where they had killed one of our People. The General thereupon leaped on the first Horse, and immediately marched the Highland Company, who were then under Arms, and ordered 60 from the Guard to follow. He himself galloped with the Indians to the Place, which was just within the Woods, about a Mile from hence, where he found Captain Sebastian Santio, and Captain Mageleeto, with One Hundred and Twenty Spanish Troops, and Forty Five Spanish Indians. Captain Grey with his Chickesaus, Captain Jones with his Tomo-

hetaus, and Tooanohowi with his Creeks, and the General with six Highland-Men, who outran the rest, immediately charged them. Capt. Mageleeto was killed, Captain Sebastian Santio taken, and the Spaniards entirely defeated. The General took two Spaniards with his own Hands. Captain Mageleeto having shot Tooanohowi in his Right Arm, as he rushed upon him, the latter drawing his Pistol with his Left Hand shot him through the Head. The General pursued the Spaniards for near a Mile, and halted at an advantageous Piece of Ground, till the Guard came up, when he posted the Highlanders on the Right, and the Guard upon the Left of the Road, concealed in a Wood, with a large Savannah or Meadow in their Front, over which the Spaniards must pass to come to Frederica. After that he returned, and ordered the Regiment, Rangers, and Companies of Boatmen to march. Whilst they were preparing, we heard Platoons firing. The General immediately got on Horseback, and riding that Way, met three Platoons on the Left coming back in great Disorder, who gave him an Account, that they had been broken by the Spaniards, who were extremely numerous; notwithstanding which he rallied them, and he himself rode on, and to his great Satisfaction found, that Lieutenant Southerland, and the Platoon of the Regiment under his Command, and Lieutenant Mackay with the Highlanders, had entirely defeated the Enemy, who consisted of 300 Men. Don Antonia Barbara, who commanded them, was made Prisoner, but mortally wounded; they also took several of the Grenadiers and the Drum: The General then ordered all the Troops to march from Frederica to him, and as soon as they arrived, pursued the Enemy with them four Miles. In the two Actions there were one Captain, one Corporal, and 16 Spaniards taken, and about 150 killed. The rest are dispersed in the Woods, for the General halted all Night at a Pass through the Marshes, over which they must go in their Return to their Camp, and thereby intercepted them. The Indians are out, hunting after them in the Woods, and every Hour bring in Scalps.

July 8. Before Day-break, the General advanced with a Party of Indians to the Spanish Camp at St. Simon's, and found them all retired into the Ruins of the Fort, under the Cannon of their Men of War; upon which he returned thither, and about the same time a Party which he had drawn from Fort William arrived, notwithstanding the Spanish Fleet lies between us to cut us off from that Place.

Florence, September 29. Cardinal Gotti, a Dominican Friar, died the 17th at Rome, which makes a Fifteenth Vacancy in the College of Cardinals. The Courier who carried the Pope's Remonstrances to the King of Spain, against the Return of the Spaniards into the Ecclesiastical State, was stopp'd between Genoa and Antibes by the English Men of War, whose Officers opened his Dilpatches, and then let him pass. The Bishop of Gork-having demanded Satisfaction of the Pope for a affront put upon Don Ciccio Puffano, the Judge, who was the Queen of Hungary, has been thereupon taken into Custody. The Spaniards give out that M. de Gages's Army consists of 16,535 effective Men: The several Detachments of it joined at Fano the 21st Instant, and are marching by Catolica to Rimini; where they are to wait for further Orders from Spain.

Turin, Sept. 29, N. S. The King of Sardinia let out this Morning for the Frontiers of Savoy towards Mount St. Bernard. One Column of his Troops are assembled there, and was for nothing but his Sardinian Majesty's Arrival to see Savoy that Way, while Baron Schulemberg, at the Head of another Column, enters by Mount Cenis, and the Valley of Morienne: They are ordered to join his Sardinian Majesty by the Vanocis near Modifiers, the Capital of Tarantasia. Both these Columns are preceded by a Body of two or three hundred Vaudois, of whom the Spaniards have the greatest Apprehensions, and who have already handled a Detachment of theirs pretty roughly near Modane, and killed the Captain who commanded it. The Spanish Army under M. de Gages, was expected Yesterday or this Day at Rimini, and, by all the Accounts we have, seem to propole nothing more at present than extending their Troops in those Parts, as well as towards Cesena and Ravenna, for securing their Substantice.

Stockholm, October 1. M. Benzelius, the Bishop of Linkoping, has been named and appointed Archbishop of Upland.

Danzig, October 10, N. S. By the last Letters from Finland we hear, that Feldt Marshal Count Lasfy, having sent a Detachment of his Troops from Helfingsfors to Abo, to take Possession of that Place, the Inhabitants immediately submitted, and took the Oath of Fidelity to the Czarina.

Copenhagen, October 13, N. S. Their Danish Majesties and the Prince Royal came to Town again on the 11th Instant. Yesterday the Court and Council was held at the new Palace, and To-day every Thing is disposed for their Return to Fredericksbourg.

Dresden, October 17, N. S. Marshal Maillebois has proclaimed throughout his Army, that all Soldiers who make any Incursions on the Saxon Territories, shall be punished with Death. There is no News of Importance from Bohemia since the 14th Instant. We hear that the Great Duke has detached about 10,000 Men after the

French Corps that pierced by Elmbogen. The Uhlans are active in defending this Country against the French Marauders, and the Bavarian Hofsars - Part of Marshal Bellefils's Baggage, sent from Prague to Francfort, passed by here Yesterday.

Whitehall, October 16.

The King has been pleased to constitute and appoint John Wynyard, Esq; to be Colonel of the Regiment of Foot, lately commanded by Lieutenant General James Tyrrell, deceased.

Kensington, October 14.

This Day the Duke d'Aremberg had a private Audience of his Majesty; to which he was introduced by the Right Honourable the Lord Carteret, one of his Majesty's Principal Secretaries of State, and conducted by Sir Clement Cottrill Doermer, Kt. Master of the Ceremonies. He was afterwards presented to his Royal Highness the Duke, and to their Royal Highnesses the Princesses Amelia, Caroline, and Louisa, at the Circle in the Drawing-Room.

Where was likewise presented to his Majesty, and the Royal Family, Lieutenant-General Count Chanclos, Governor of Ottend, which came with the Duke d'Aremberg.

Note, That Letters going out of Great Britain (except to France, Holland, and Flanders) have by the ancient Usage of this Office paid the Foreign Postage, and are required by the Act of Parliament to do, at the Office in Great Britain where the same are first put in.

Note also, That if such Letters to Foreign Parts are put into any of the Country Offices, the Inland Postage of such Letters in London must also be paid on passing the same into such Office.
