Yesterday, at ten o'clock, the Right Honourable the Marquis de la Fayette, embarked on board the *Nymph's* barge, which was waiting for him at the Whitehall Stairs; he was accompanied thither by his Excellency Governor George Clinton, the Generals Green, Webb, and Lamb, the Consul of France, Colonel Fish, many other brother officers, and a vast concourse of citizens; as he passed the battery he was saluted with thirteen guns; some little time after he got on board, the King's frigate saluted the American flag with a Continental salute, which was returned by the artillery of the fort with an equal number: The Marquis was handed on board the barge by his Excellency the Governor on the one side, and on the other by the Consul of France.—God grant the good Marquis, a safe, an agreeable, and a quick passage to his native country—he carries with him the well earned blessings of a grateful people.—The Packet *Le Courier de Europe*, failed at the same time with the November mail for Port L'Orient.

The late of New-York owes great obligations to the gentlemen chosen to represent her in Congress, five, the entire number chosen being at present at Trenton.

The Mayor, and the other agents for this State, in the litigated claim of the Massachusetts, set off on Thursday last for Philadelphia, and were to return as yesterday. Their errand was owing to the want of some necessary papers, which they expected to meet with in Philadelphia.

There cannot be a doubt but what the seat of Congress must be permanently fixed in one or other of the great towns, instead of residing in such a village as Trenton, or any other small place. All government must depend materially on the good opinion of the people, and altho' there is not a more popular legislature on earth, than Congress, yet from the great influx of foreigners into this country, that good opinion may be greatly weakened by the pompous, inflated accounts of the extraordinary magnificence with which kings, and rulers of other republics assemble in different parts of the world; this misfortune admits of an immediate remedy.—New-York, if properly considered, affords a situation at once central and inviting: The salubrity of the air; the regular station of the European packets being fixed here, and the facility with which elegant and commodious apartments could be fitted up, all combine to recommend this city as a place most happily adapted to the session of Congress.

By a correspondent from New-Haven we have information, that a Negro who had served in the Continental Army during the war, and had been discharged with full certificates of goodbehaviour, was apprehended, at the instance of his late master, and committed to prison as a runaway servant; being advised to sue out a bill of Habeas Corpus, he was in consequence thereof brought before the Supreme Court, at that time sitting, and his master appearing, claimed him as his property, and slave for life. In the examination of the cause it appeared, that sometime in the year 1777, being the property and slave of the claimant, he enlisted into the Continental Army, for, and during the war, with the consent, licence, and permission of his master, who received the bounty given for his enlistment. Whereupon it was resolved and decreed,—That, as at the time of the enlistment, no person but a freeman could by the resolutions of Congress be enlisted into the Continental Army, the consent of his master to the enlistment amounted in law to a complete emancipation; that he was no longer a slave, but had a right to his personal liberty. It is to be hoped from the known liberality of sentiment, and attention to liberty which is so much the character of our judges, that negroes in similar situations in this State (and there are not a few) may be encouraged to apply in similar manner for that liberty to which they are entitled as a reward for their spirit and courage.

Extract of a letter from Shelburne, dated November 15.

"This place exhibits a most striking view of the numerous and solid advantages which may be derived from the efforts of industry and perseverance. It is not nineteen months since impenetrable and dreary woods bounded the sides of this excellent harbour; anxious as those persons were to complete their determination of building a town, yet the disadvantages preponderated so highly against the expected advantages, that they were some time undetermined whether to settle here, or endeavour to find out a more inviting and eligible situation. We have now a town, well laid out to the east, and fine improvements from Roseneath-Island, on both sides to the town; but the most material and pleasing circumstance is the prospect of an extensive commerce, there being at this time upwards of sixty full of vessels lying in this harbour, and some of considerable bulk.

"We had the misfortune, a few days ago, to lose Mr. Alexander Robertson, late an eminent printer in New-York; a man of superior abilities in the line of his profession, and highly valued and lamented by a most respectable and extensive acquaintance."

KINGSTON, (Jamaica) Nov. 13.

By a gentleman who left St. Kitts a few days ago, we are assured, that a vessel had arrived at that island from Barbadoes, the master of which reported, that on Monday the 18th ult. being then at anchor in Carlisle-Bay, a most dreadful earthquake happened at Barbadoes, preceded by a deluge of rain, which did great damage all over the island, and sunk two sugar plantations bordering on the sea, in the parish of St. Andrew, commonly called Scotland, no vestige of which remain at this day; the whole space which these estates occupied being covered with salt water.—He further reported, that he did not wait until five days after this calamity, and that the convulsion of the earth was still felt when he took his departure, by which many lives were lost.

The pirate Johnson was brought to the Court-House on Sunday, on pretence of making further discoveries relative to the late horrid murders committed on the high seas; but having procured a quantity of liquor, he rendered himself so beastly drunk, as to be scarcely able to utter a word. He was therefore re-conducted to goal, and again secured in irons.

On Wednesday last, the Honourable House of Assembly of this Island presented the following Address to his Honor the Lieutenant-Governor:

May it please your Honor,
WE, his Majesty's dutiful and loyal subjects, the Assembly of Jamaica, offer our most grateful acknowledgements for the blessings we enjoy, under God, thro' the necessary, humane, and judicious policy of your Honor, in permitting the free importation of provisions and lumber, in foreign bottoms, to this Island.

Sorry are we to inform you, Sir, that the same necessity which induced your Honor to grant this permission for four months, still exists, and pleads for a longer continuance. It is impossible for the natural productions of this country to come to such maturity, as to be wholesome food, before the end of March next.

Fully sensible of the delicate situation in which your Honor stands, necessity alone impels us to solicit from you a prolongation to that time;—trusting that, before that period, Government will see the impolicy of your conduct towards us, and allow such an intercourse with the United States of America, as only can prevent a repetition of those wants and distresses which we have, within these four years, so severely felt.

To which his Honor was pleased to make the following Answer:

Mr. Speaker, and Gentlemen of the Assembly,

NOTHING but extreme necessity, arising from our late unforeseen calamity, could have justified me in even a temporary deviation from regulations to which, without deciding upon their policy, I feel myself called upon strictly to conform.

The resolutions of Council, under which we are at present supplied with provisions and lumber in foreign bottoms, limit the time thereof to four months, and until further orders; lest the necessity for such supply should continue at the end of that period, a considerable part of which is still unexpired.

If it shall hereafter appear that the same necessity exists which occasioned that measure originally, I shall certainly think myself at liberty, some time before the end of the period now limited, to prolong it for such farther time only as shall then appear to be absolutely and indispensably necessary; for, as I cannot deserve, I am certain I shall never enjoy, the good opinion of so respectable a Body as that which I have now the honor to address, but by a faithful discharge of the trust reposed in me by my Sovereign, and the duty which I owe to that Community of which we are all Members.

CHARLSTON, Nov. 16.

The printer of the *South Carolina Gazette* has been involved in an altercation, which promises very little satisfaction. Several inflammatory publications having appeared in Mr. Miller's paper, tending to reduce the exalted character of Commodore Gilton, that gentleman sent for Mr. Miller, and interrogated him respecting the author of the obnoxious publications: The answer was so truly in the Jesuitical stile of St. Omers, that it is worthy of being repeated:

Commodore Gilton. My feelings have been exceedingly hurt by a publication called, *The Commodore Ouzmaneuver*.—I have never had an opportunity till the present of enquiring of you who the author was of the *Adulations* to that piece.—In the opinion of my friends, the ad-

tions contained in that letter were trifling in their effect compared to the additions.

Mr. Miller. I am surprized at such a quest on from you, Sir. You may with equal propriety put the same to any other person. The paper was anonymous, and like other pieces published on such occasions, took only that warranted liberty which every free government allows, that of scrutinizing the characters of men who offer themselves candidates for public trust and public favor.

This sort of reasoning not being much relished by the Commodore, he bluntly insisted upon a plainer explanation of the fact, and the printer was at last induced to own that HE was the author of the obnoxious publication: The Commodore returned this confession with no plentiful dose of the *Argumentum Baculum*, as to almost entirely annihilate his mental, corporeal and risible faculties.

Mr. Miller has appealed to the laws of his country, which he insists have been infringed and insulted, by the chastisement which he has recently received.

LONDON, October 24.

Nothing can be more flattering to the Bishop of Osnaburg, than his reception at the Imperial Court. To be treated with distinguished respect by the first Prince in Europe, not only in dignity but in abilities, and at so early an age, is a mark of uncommon merit, and it must not only give his parents the utmost satisfaction, but fill the nation with the most pleasing hopes, that so bright a dawn will be followed by a blaze of glory, which will be equally an ornament to himself and an emolument to his country. To him we may apply the celebrated compliment of Virgil to the son of Pollio.

Magna spes altera Romæ.

Government, among other weighty matters lying on the Cabinet, have the settlement and cultivation of the remaining parts of Jamaica. It is an exact survey we report from, when we say, that an entire third part of that large and valuable island, yet continues unexplored.

When Mrs. Hayley set sail for America, she carried with her Dr. Moyes, of Scotland, who last winter gained the hearts of all the ladies, notwithstanding his blindness, by his Lectures on Natural Philosophy.

From the situation of the French finances, all ideas of their infringing the late peace, for some years at least, are improbable; and both the French King and the Cabinet, are so pacifically inclined, that, from the appearance of politics, there is more reason to expect a closer alliance with that country, from the alteration of affairs in Portugal, than has subsisted between Great-Britain and France for many years.

Letters from Scotland, by the last post, advise, that the inhabitants of Kircudbright, Dumfries, and several other burghs, have joined the general association at Edinburgh, for the purpose of bringing about a parliamentary reform, and signified their intentions of enforcing it by every legal and constitutional measure. The Scotch now look on a more equal representation not only as a privilege to which they have a legal and indisputable claim, but as the touchstone of the present ministerial system of government, and as one of the first conditions on which the Minister will be entitled to their confidence and support.

The Opposition writers are bringing Mr. Pitt and Miss Pulney together, preparing their marriage settlements, sporting 170,000*l.* of the public money on the occasion, and giving Mr. Pulney a peerage, and all this in half a dozen lines of a newspaper; and what is more extraordinary, without the parties having said a single word on the subject!

Lord Harrington's new born child drew its first breath in the barracks of Dublin, as Sterne did in the barracks of Clonmel, in the county of Tipperary. If wish should preclude at births in such places, and Sterne is certainly no proof to the contrary, the young Stanhope may one day equal and surpass his witty kinsman the great Earl of Chesterfield.

The Irish Bishop, (*Lord Harvey, Bishop of Derry*), has been repeatedly solicited to employ his purse in a certain cause, but he don't like it.—*For 't's a grown prudent in licentious days, Some rogues he pays with pors' and some with praise;* But no money—no—no—not a farthing—no money.

A few days ago, a person at Stockwith, in Yorkhire, formerly a servant to a lady at Lincoln; sent her a written note, begging her acceptance of a *small* present. The present which arrived a few days after, was a single coal, upwards of 2500 weight.

DIRECTIONS FOR WALKING THE STREETS OF LONDON.

(Concluded from our last.)

If you meet a wheelbarrow, be sure to give it the wall, although you have the kennel, because wheelbarrows have a better right to the pavement than foot passengers; and although it be your office to

prevent such nuisances, yet you know no man is obliged to do his duty.

If you meet with a fine woman, turn about and stare after her, assuring your companions that you know her well, and that she is common as a barber's chair. If one of them happens to know her, and contradicts you, you must say, that "the was likeli to the one you meant that possibly could be."

If you meet a porter with a heavy load, which he seems very unfit to bear, never give him the way, because if you force him off the pavement, he has a chance to let fall his load, and fall himself, which may be a warning to such wretches in future.

If you have a watch, which you are fond of displaying, keep it in your hand, and make the chain dangle, and stop at every church to examine how it goes, as by these means the Public may be made acquainted with the elegance of your time piece; and if a pick-pocket takes a fancy to it, why every body knows the watch, and you may have it again.

Stop at every print-shop, particularly if you have five or six in company, and crowd the way. If you see a raw country girl viewing the prints, be sure to say something very indecent in her hearing, or point at some very indecent print. This is genteel and buckish, and shows your spirit.

If you see a crowd, rush into it headlong, for whether it be occasioned by a ballad-singer or a dead sow, one way as well know, and the pick-pockets will be very thankful.

If you see a fire engine driving along, be sure to follow it as fast as possible, and don't be interrupted by a fruit-stall, or so; and when you come to the place where the fire is, stand still, stare, and look up, and do nothing, then return home and say you saw the fire, and it was very terrible, indeed.

If you leave the playhouse, and meet with the girls of the town who ply near Drury and Covent Garden, take the first that offers, say pretty things to her, and permit her to take hold of your arm; when you have got her a mile out of her way, laugh in her face, *be! be! be!* and show your inhumanity by leaving her to thift for herself.
